1. When did City Council Authorize the Senior Center Advisory Committee?

On June 19, 2012, the City Council and the Successor Agency (formerly the Redevelopment Agency) authorized moving forward with the Design-Build concept for the construction of the new Senior Center in the City of Inglewood. To keep the senior community and other stakeholders apprised of the project's process and progress, the City Council and the Successor Agency authorized the formation of the Advisory Committee.

2. What is the primary purpose and function of the Advisory Committee?

The Advisory Committee is to act in an advisory capacity to the City Council, Successor Agency, and City staff in matters related to the development of the new senior center, and advancing completion of the facility. Other responsibilities of the Advisory Committee include acting as emissaries to the community at-large and to act as an information conduit for the community during the crucial planning and construction phases of the project.

3. What is the composition of the Advisory Committee?

The committee is comprised of 15 community members; five of these appointed by the Mayor and City Council. The remaining 10 members are appointed by the City's Department of Parks, Recreation and Library Services.

4. When does the Advisory Committee meet?

The committee meets regularly every third Monday of the month at:

These meetings are open to the public, and all members of the community are encouraged to attend.

5. How large will the new center be?

The center is proposed to be an approximately 35,000 square foot, two-story, above-ground facility with two levels of underground parking.

6. Where will the new center be?

The new center will be located at 111 Locust Street, Inglewood, CA 90301.

7. Who will the new center service?

Once built, the center will be the focal point for social services for residents 50 and over, in Inglewood as well as Hawthorne, Lennox, and Ladera/Windsor Hills.

8. What amenities will be in the new center?

The amenities will include a main lobby area, multi-purpose rooms, an exercise area, billiard and game rooms, television room, computer lab, central kitchen and dining facilities, and care management and transportation offices.

9. When will the new center open?

The Advisory Committee continues to provide input and monitor the design of the new center. Ground-breaking for the new center occurred on February 29, 2016. With full-construction underway, Grand Opening of the new center is scheduled for November 2017.
